The PANACEA project

- > What is it: IT system, which will allow to generate the individual rehabilitation plan in an automated manner,
- > Target audience: patients with advanced breast cancer (Metastatic Breast Cancer),
- Focus: non-medical problems,
- **Goal**: maintaining an optimal level of quality of life.

Role of Reha-manager in Metastatic Breast Cancer patient's care

Since 2018 the number of BC patients in BU of UCC in Gdańsk is growing: 355 in 2018 475 in 2022

approx. 20% are MBC patients
with complex and very individual needs

oncologists surgeons nurses psycho-oncologists dietitians physiotherapists reha-managers

- <u>Reha-manager</u> is a specialist responsible for a design, management and implementation of a complex rehabilitation process of a patient
- > Focus on non-medical aspects such as providing information on:
 - where and how to find social support,
 - which public or private institutions may be of help,
 - how to adapt their lives to MBC reality
 - where to look for a non-medical support, assistance in daily self-care activities,
 - how to improve their quality of life.
- This process is being implemented based on the individually prepared REHABILITATION PLAN.








Reha-manager & manual rehabilitation plan

- Plans used to be prepared MANUALLY by reha-manager based on the information received from the interview with the patient, and excel spreadsheets,
 Long and time consuming processs several plans per week only.

What PANACEA does?

PANACEA is a system designed to generate an individual complex rehabilitation plan based on the Strengths Weaknesses Opportunities Threats (SWOT) analysis of the information provided by the MBC patient in an Contains a list of patients imported form the HIS based on ICD-10 code,

Generates a link with individual survey sent to patient via text message.

A SWOT analysis of the answers provides. **AUTOMATED** manner.

- > Enables coding according to the International Classification of Functioning, Disability and Health (ICF) and identification of service/care providers based on the postal code – relevant regional/local providers/institutions/NGOs etc.,
- > Plan can be edited/adjusted at any time by the reha-manager and sent to the patient via text message again.













PANACEA: Text message with the survey








Patient's survey content






OUALITY OF CARE IMPROVEMENT IN MBC PATIENTS


Survey on-line – open questions







SWOT Analysis based on survey questions



Re-evaluation of the plan and the process

Evaluation survey – to check the patient's satisfaction in relation to the needs indicated in the initial survey:

- What **has changed** in patient's situation?
- Are there **any problems** that have **not been addressed**?
- Evaluation is carried out after the completion of treatment or the period planned for implementing the plan,
- Justments are done on an adjusted according to the patient progression, family situation etc.). Currently all MBC patients are still in the process of plan's implementation thus no the final evaluation is possible – adjustments are done on an ongoing basis after a contact with a patient,
 - Plan is adjusted according to the patient's suggestions or the changing situation of the patient (disease








Analytical module of PANACEA – statistical analysis

Statistical analysis by age, by place of residence, by most common strengths, weaknesses, opportunities and











- Improving patient's care focus on the patient and easier communication with the patient on complex issues via survey,
- ➤ Patient's engagement active participation in planning the rehabilitation process, reducing the negative consequences of the disease, feeling of control over the situation and influence on life,
- > Cost reduction by saving time and involvement of medical teams relieving doctors, nurses and other specialists in the field of preventive, information and educational activities, etc., saving time of reha-manager's work,
- > **Optimisation** of action of many specialists, coordinated activities of many institutions and people managing the complex situation of a patient (health, social and professional situation),
- ➤ Maintaining control over non-medical (socio-economic, logistical, etc.) problems during treatment, faster diagnosis of patient problems,
- > Transferability of PANACEA system to other medical centres and teams, e.g. within the UCC, in Poland and other countries,
- A tool for scientific and statistical research,
- A training tool for future reha-managers.
